Policy and guidelines for the Scholarships/Financial Support to Students

1. The College Shall Provide the necessary information about the scholarships at the beginning of academic Year.
2. The list of Government / Non-government scholarships. All the notifications/circulars/brochures/other publicity materials received by the college will be prominently displayed.
3. There is a section in the college office to address the queries and guide the students.
4. The college is registered on all the scholarship portals of the Government and is also registered with all the departments which sanction scholarships to the students.
5. The college ensures that the name of the College along with institutional id/code is there in the portal for the easy and successful submission of the application by the students.
6. verification, e-verification, attestation, e-attestation are done as per the procedure.
7. The college office shall process all the application on time.
8. Students are assisted and guided in addition to establishing liaison with the governmental Departments and other agencies as required under the procedure.
9. The information is also displayed on the student's notice boards and common notice boards
10. It shall be the duty of the students to register and apply for the available scholarships as per the eligibility criterion.
11. Institutional endowments shall be disbursed to the eligible students by the college based on the endowment guidelines. Here the merit is considered.
12. There should be good academic track record to avail academic endowment scholarships/prizes
13. Students should not have any backlog in any subjects.
14. The institutional financial support is considered depending upon the availability to avail the sponsored funds.

15. Eligibility to avail the scholarships shall be merit-cum-means.
16. Scholarships Meant for needy students and shall reach the right beneficiary.
17. The College is committed to keep the students informed about the scholarship and provide necessary assistance
18. Request for attestation, bonafide certificate fee statement etc shall be addressed immediately
19. For online scholarships the students are required apply online only. Students are provided with all the necessary guidance and they have to apply on their own.
20. For any further information and assistance on scholarships, the students can contact the concerned section in the administrative.

Procedures:

At the time of admission itself the students are given information about various scholarships, the scholarship information systems and portals of the state government and Central Government. Students are told to have their bank account and get the aadhaar needed to it. Submission of the all the particulars such as income certificate, cast certificates, and other applicable documents are mandatory. Information about DBTF (Direct Benefit Transfer) is given as almost all of the government scholarships are disbursed directly to the bank account of the beneficiary.

The students/parents/guardians are advised to visit the national scholarship portal and state scholarship portal and complete the registrations. They are advised to keep the following details/documents ready while registering –

- Aadhar Number
- Bonafide certificate/study Certificate
- Scanned copy of the first page of bank passbook
- Caste certificate
- Income certificate

Muslim Pachha Peth, Solapur as a Religious (Muslim) and Linguistic (Urdu) Minority Educational Institution.

This certificate will be applicable only for the state of Maharashtra. Religious and linguistic minority status will remain applicable to all the academics branches run by the said institution.

The Religious Linguistic Minority Status hereby granted to the above mentioned educational institution shall be valid from the academic year 2010-11. Criteria and conditions, prescribed under Minorities Development Department, Government Decision No. Ashes-2002/Pro.No.133/2008/Ka.1, dated 4th July, 2008 should be fulfilled by the concerned organization consistently and directivity.
